Memorandum of Understanding (MoU)

This agreement is entered into between the Benazir Bhutto Shaheed University of Technology and Skill Development, Khairpur Mirs, herein after Executing Agency for imparting technical/ skill development trainings in various fields /trades including Advance Food Processing and Packaging trades sponsoring by Benazir Bhutto Shaheed Human Resource & Research Development Board, Government of Sindh and M/S Al-Syed Foods Product Industry, Khairpur herein after called Partner Industry for imparting training in Advanced Food Processing and Packaging Trade. This agreement is signed on the 13th day of October 2021 between the Benazir Bhutto Shaheed University of Technology and Skill Development, Khairpur Mirs and Al-Syed Foods Product Industry, Khairpur Mirs. The details of agreement are as under:

Name of Trade for jointly imparting Training : Advance Food Processing and Packaging
Number of Trainee to be trained : 30 per Batch
Duration of Trade Training (one year) : 06 Month per Batch
Number of Batches to be trained : 02 Batches (60 Trainees)

Background: The Benazir Bhutto Shaheed University of Technology and Skill Development, Khairpur Mirs was established by the Government of Sindh in April 2016. The purpose of establishment of this University is to promote and provide quality skilled/technical education to reduce the unemployment in the province. The University has established Skill Development Centre since its inception. The Skill Development Centre is offering different Diploma and Certificate courses in the technical, vocational and commercial fields and also plays key role to develop liaison with the local industry in order to strengthen Academia –Industry Linkages.

Role of the Al-Syed Food Industry (Partner Industry) for Imparting Training of Trade Advance Food Processing and Packaging:

- A group of 30 trainees (Male/Female) having requisite qualification (Minimum Class –V) and age from 18 to 35 Year having valid CNIC will be jointly selected as per defined criteria by the partner Industry and the University.
- Space for Training within the Industry will be provided by the partner Industry.
- Foods for packing and processing practice (Experiment) will be provided by the Industry.
- Assistant Trainer will be provided by the partner Industry.
- Attendance of Registered Trainees will be ensured by partner Industry and attendance record will be maintained on regular basis.
- Drinking water arrangement for trainees will be made by the partner Industry.


B. Role of the Benazir Bhutto Shaheed University of Technology and Skill Development, Khairpur Mir

- (a) The Training Trade will be got approved from Benazir Bhutto Shaheed Human Resource and Research Development Board, Government of Sindh by the University.
- (b) All Rules, Regulations and guidelines pertaining to the training provided by BBSHRDB for the trade will be complied both the University and partner Industry.
- (c) Stipend for trainees approved and provided by the BBSHRDB will be disbursed jointly among the trainees in the form of cross cheque as per trainee's attendance policy of BBSHRDB, Government of Sindh
- (d) Packing material (Raw material) as approved by BBSHRDB per month will be provided to the partner Industry.
- (e) Stationery items as per requirement will be provided from the approved trade budget.
- (f) Master Trainer will be provided by the University and the remuneration/salary for Master Trainer and Assistant Trainer will be given as approved by **BBSHRDB** on monthly basis in the form of cross cheque and after submission of attendance.
- (g) Personnel Protective Equipment (PPEs) as per requirement of trade will be provided by the University from the approved budget of Trade.
- (h) Seating arrangement Stools/Class chairs will be arranged by the University as per approved trade trainees.
- (i) The non-consumables will be retained at the partner Industry and will be used by the trainees of the University-Industry in future.
- (j) Training Board will be provided by University and displayed by the partner Industry in front of Industry as per requirements of sponsoring Agency i.e. **BBSHRDB**
- (k). This agreement will be for one year period to train two batches in the Advanced Foods Processing and Packaging Trade.
- (l). This agreement shall not be withdrawn during the training session from the either side.
- (m). This agreement will be effective from the date of start of the Training for the trade "Advanced Foods Processing and Packaging."
